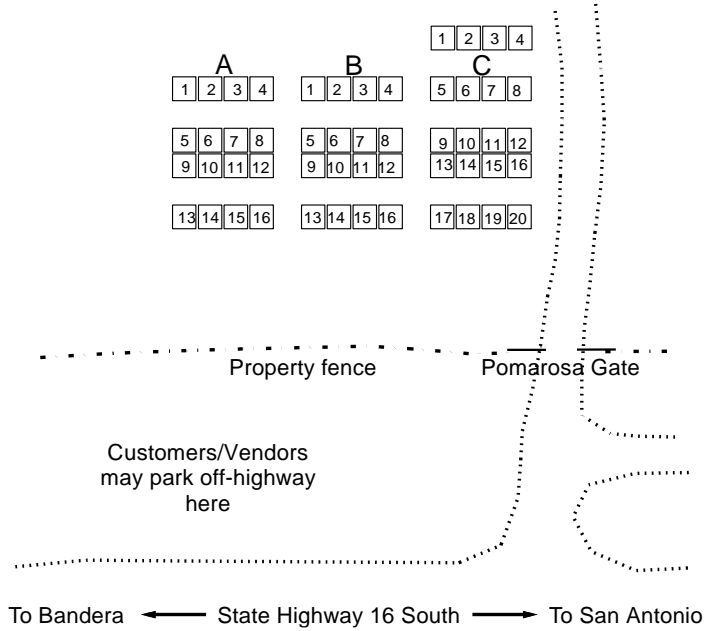


POMAROSA MARKET DAYS
